GENERAL LEGAL TERMS AND CONDITIONS.

PLEASE READ CAREFULLY, BY ACCEPTING AND/OR SUBSCRIBING TO A HOPE HEALTH PRODUCT OR SERVICE YOU HAVE AGREED TO THESE TERMS.

DEFINITIONS

These definitions apply to terms used in this page and on any product category page throughout the **Subscription Terms Related to Hope Health Products and Services**.

If we use “**Standard Terms and Conditions**”, we mean the terms and conditions identified in this page, or pages devoted to a specific product category, all of which apply to your purchase or subscription of a Hope Health product or service.

“Articles” as used in these Subscription Terms means individual articles included within the Hope Health Library.

“Customer” or “You” as used throughout these Hope Health Subscription Terms refer to the person or legal entity who has subscribed to or purchased the Hope Health Product. By purchasing or subscribing, the person who subscribes or purchases the Hope Health Product represents that he or she has the authority to enter into such agreements with Hope Health.

“Customized Product” means a Hope Health Product prepared by Hope Health according to specifications of the Customer which might include proprietary material provided by the Customer.

“Hope Health Content” means copyrightable work, in the form of text, graphic art, video, or sound, prepared by Hope Health in either print or electronic format, which may include trade or service marks, or trade dress, all or part of a Publication, sometimes referred to as “Licensed Materials.”

“Hope Health Publication Delivered Electronically” means a full publication, including a Customized Publication, purchased from Hope Health in an electronic format.

“Hope Health Library” means the library of individual Articles kept and maintained by Hope Health.

“Hope Health Publication” or “Publication” means a print or electronic work of art, in the form of a newsletter, calendar, brochure, or other complete publication produced by Hope Health.
